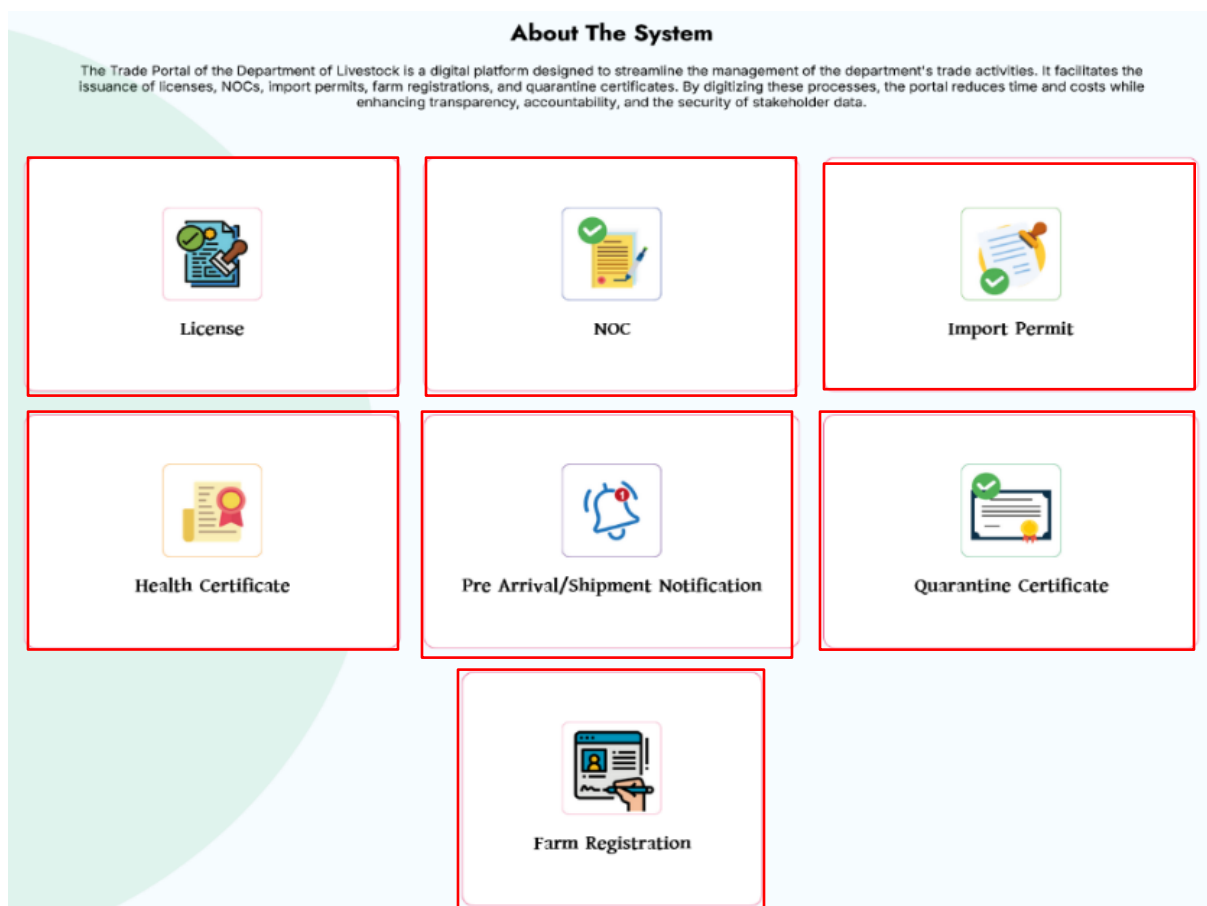

If the OTP is not received, click the **Resend OTP** button after waiting for 2 minutes and 30 seconds.

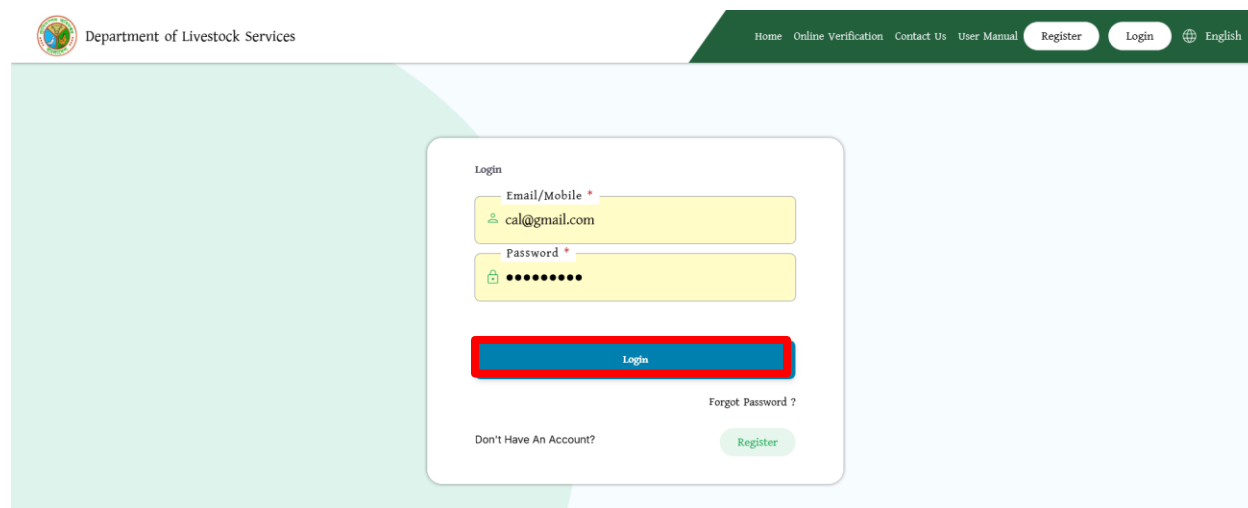

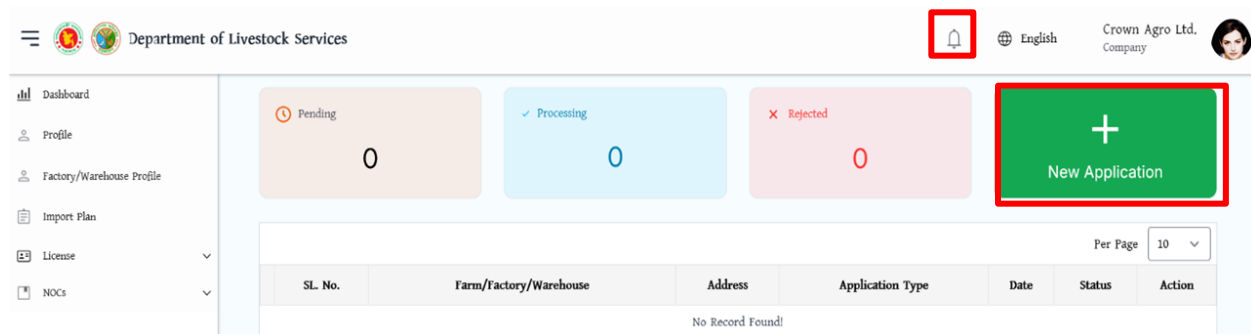
How does an applicant apply for a G.P. Stock and Snake/Crocodile Farm?

To apply for a **G.P. Stock and Snake/Crocodile Farm**, the applicant needs to click on the Farm registration menu, which directs him/her to the page for creating a new application. Adding a New Application
